Course: outdoor, 25 yard, 6 lane heated pool. Colorado start, watch timing. Warm down pool is available.

Eligibility:

1. Open to any 2007-2008 USA Swimming registered swimmer registered as of the entry deadline.
2. No on deck registration will be allowed.
3. Age on October 14th will govern for the meet
4. A current USA registration card must be presented at the clerk of course if requested. All coaches and USA registered officials must wear their current USA Swimming registrations in a visible manner. Out of state athletes must include a copy of their USA registration.
5. This is a no time standard meet.
6. Swimmers with a disability are welcome to enter this meet. The coach or entry chairperson must alert the meet director, referee, and entry coordinator as to the need for any special accommodations or seeding arrangements at the time the entry is submitted.
7. High School athletes competing with a high school program are not eligible to compete in this meet.

Rules:

1. The current rules of Competitive Swimming will govern.
2. Individual events are pre-seeded and timed finals.
3. Swimmers are limited to 4 events per sessions.
4. The controlled meet warm-up will be posted and enforced.
5. Time Trials will not be offered.
6. NTS meets include a session for 10&U, 11-12, 13-14, and 15-O. 8 & Under swimmers may swim in the 10 & Under events only if they have a minimum of 1 AG regional meet qualifying time for the events being offered in the meet.
7. All coaches and officials must be USA Swimming registered prior to the competition.
